FORENSIC EXPERIENCE:

I have been in private practice in Minneapolis, Minnesota for more than 35 years. During this time, in addition to a clinical practice treating children and adults, I've also been involved in the practice of forensic psychology.

Over the years, I completed over 1,700 forensic evaluations. In total, I've testified as an expert witness more than 500 times in a variety of court settings in the State of Minnesota, as well as

nationally. I've been hired by both the defense and plaintiff, in addition to being frequently appointed as a neutral examiner by the court. Finally, I've been hired and qualified as an expert in PTSD by the United States Army and the United States Navy.

The psychological assessments and expert testimony I have provided include the following areas and issues in Forensic Psychology:

<u>Civil Suits Involving Claims of Pain and Suffering, and Emotional Distress</u>: I conduct evaluations of adults and children in civil suits where pain and suffering and emotional distress is alleged. And I've evaluated litigants involved in car accidents; litigants injured by physical and sexual assault; employment-related cases, including claims of harassment and discrimination; and alleged emotional trauma related to a wide variety of other physical injuries.
